

PRIVACY NOTICE FOR OLAF ANTI-FRAUD COMMUNICATORS' NETWORK (OAFCN) CONTACTS

1. DESCRIPTION OF THE PROCESSING OPERATION

This processing operation consists of (a) maintaining a mailing list containing email addresses of the members of the OAFCN used by the European Anti-Fraud Office (OLAF) competent staff to contact them and (b) providing professional and contact information about the members on the OLAF website. The OAFCN members are spokespersons and officials responsible for communication matters in OLAF's partner services.

The processing of your data will not be used for an automated decision making, including profiling.

2. LEGAL BASIS FOR THE PROCESSING

The legal basis for this processing operation is Art. 2 of Commission Decision of 28 April 1999 (OJ L136/20 of 31 May 1999); the autonomy granted to OLAF by Regulation No. 883/2013 (OJ L 248, 18.9.2013, p. 1) and Article 5.1 paragraph a of Regulation(EU) 2018/1725.

3. CATEGORIES OF PERSONAL DATA COLLECTED

In order to carry out this processing operation OLAF collects the following categories of personal data with respect to members of the OAFCN:

- a) for the mailing list: email addresses
- b) for the website: name, surname, professional and contact data, including a photo if they wish.

The provision of the personal data is not mandatory (but is voluntarily provided by OAFCN members).

4. WHO HAS ACCESS TO YOUR INFORMATION AND TO WHOM IS IT DISCLOSED?

Access to the email list is provided to OLAF staff responsible for communications. The website information, provided by the OAFCN members, is publicly available.

5. HOW DO WE PROTECT AND SAFEGUARD YOUR INFORMATION?

In order to protect your personal data, a number of technical and organisational measures have been put in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the data being processed. Organisational measures include restricting access to the data to authorised persons with a legitimate need to know for the purposes of this processing operation.

6. HOW LONG DO WE KEEP YOUR DATA?

Your personal data may be retained by OLAF until you request to have your name removed from the network.

7. WHAT ARE YOUR RIGHTS AND HOW YOU CAN EXERCISE THEM?

You have the right to request access to your personal data, rectification or erasure of the data, or restriction of their processing.

You have the right to object to the processing of your data.

Any request to exercise one of those rights should be directed to the Controller (OLAF-FMB-DATA-PROTECTION@ec.europa.eu). Where you wish to exercise your rights in the context of one or several specific processing operations or files, please provide their description and reference(s) in your request.

Exceptions based on Regulation 2018/1725 may apply.
